Notification of Intent to invite National Competitive Bids Plus (NCB+) for Civil works of Berthing and Breakwater at Miinisadam Harbour

The Estonian Centre for Defence Investments (ECDI) is launching the procurement for the construction of project 2NB32001-00-ES "Berthing: Provide Harbour Breakwater" in accordance with Maritime CPP 9B1404. The authorized value of the project is 17 093 115 euros. The procurement also includes the national scope of construction of floating docks for Estonian Police and Boarderguard Board vessels with estimated value of 362 250 euros.

Construction phases:

- Stage I: reconstruction of the seaward side of berth 7;
- Stage II: dredging, reconstruction of the basin side of berth 7, reconstruction of berth 7a;
- Stage III: breakwater reconstruction.

Object parameters:

- The working area is approx. 14 000 m².
- Berth 7 length – 150 m.
- Berth 7a length – 177 m.
- Berth height above ground z=5 m.
- Breakwater length 155 m.
- Dredging volume approx. 35 200 m³.

Estonian Centre for Defence Investments (ECDI), governed by the Estonian Ministry of Defence, is responsible for conducting all defence related procurements. The bidding process will be conducted using opened procedure.

The complete set of bidding documents will be accessible in the Estonian e-Procurement registry at: <https://riigihanked.riik.ee/rhr-web/#/search> with the reference number „279484“ when the tender has been released. The estimated tender release date for the procurement is 22 July 2024 and estimated bid closing date is 23 August 2024. However. As these dates may be subject to change during the tender process, all final deadlines will be set in the procurement notice in the e-Procurement registry. The bidding documents will be „NATO UNCLASSIFIED“.

All potential bidders will have to create user and company accounts on the e-Procurement portal <https://riigihanked.riik.ee/rhr-web/#/settings/users/new> for the submission of bid proposals and all relevant documentation. Any other method for bid proposal (mail, e-mail, fax, correspondence via Estonian Delegation to NATO etc.) will not be accepted and such bid proposals will not be considered.

Declarations of eligibility, as per Annex V to AC/4-D/2261 (1996 Edition), shall be submitted to the Estonian Delegation at NATO (mission.nato@mfa.ee) and the ECDI (info@rkik.ee).

In case of need for clarifications on the bid proposal, the ECDI can ask for additional or original documents, including using channels other than the e-Procurement registry. The contract will be awarded to the lowest compliant bidder. Bidders will be required to declare a bid validity of three (3) months from the closing date for receipt bids. The bid documentation and subsequent procurement contracts will be in Estonian. Bid offers and all communication made by the bidders, including any technical data or documentation submitted by the contractors must be also in Estonian.
