Title of IFIB: IMPROVING NATO'S STRATEGIC SPACE POSTURE

Requirement: HQ SACT is seeking support from an experienced space consultancy

company (the contractor) to provide expert assistance to NATO Allied Command Transformation (ACT) in transforming its space enterprise. The Contractor shall leverage its expertise in operational planning, force

development, strategic policy, and command and control (C2)

architecture to ensure NATO's space capabilities are fully integrated into regional and strategic plans. The Contractor's team shall bring extensive experience in multi-domain integration, space effects planning, and

defense policy alignment.

HQ SACT will set out expected tasks and management structures and will request that suppliers propose a structure that best delivers the

desired ways of working.

Type of Contract: Firm Fixed Price, Deliverable Contract

Period of Performance: The base period of performance is 12 months from contract award with

four 12-month options periods.

Bidding Procedure: Best Value

Estimate cumulative amount for base year plus four-year-option years is

\$7,500,000

Classification: A NATO SECRET clearance is required for work on this task and for

access to the Headquarters and NATO SECRET Wide Area Network. A Facility Security Certification must be in place before any contract can be

awarded.

Issue Date: 10 June 2025, (target date)

Bid Closing Date: 22 July 2025, (target date)

Eligibility: Companies which have performed similar contracts within the last five

years substantially similar in scope to the requirement described in the solicitation. Contractor personnel performing services under the contract must be citizens of a NATO nation. Any contractor personnel who needs access to HQ SACT must possess at least a valid NATO Secret level security clearance. All contractor personnel must have appropriate

professional training and experience in related fields.

**Delivery location(s):** The majority of the work under this contract is expected to be performed

at the Contractor's facility, HQ SACT, or NATO HQ. The Contractor will be required to attend debrief meetings at HQ SACT. The Contracting Officer's Technical Representative (COTR) or designated representatives may request that the Contractor provide services at other locations, including

to conduct interviews and analysis.
