### NOTIFICATION OF INTENT TO INVITE BIDS

The Hellenic Navy General Staff (HNGS) intends to invite eligible companies to participate at National Competitive Bid plus (NCB+) as defined for the NATO Security Investment Programme (NSIP) for implementation works of the following NATO funded project:

"Project 3NB06258: "Provide Fuel Storage & Distribution Facilities Urgent Requirement, Souda

Naval Base, Greece"

#### 2. SUMMARY DESCRIPTION AND SCOPE OF PROJECT

The project provides the necessary civil and mechanical works in order to construct a complete fuel (DFM) storage and distribution facility located at the south section of Souda Naval Base.

The main works are:

- Dismantling and removal of the old existing tanks
- Restoration of the existing reinforced concrete wall and construction of new concrete foundation
- Tank construction
- Construction of new sediment and water tanks
- Construction of fire pump station
- New facilities for fuel pump house filter station including filters and water separators.
- New fuel pipelines

### 3. COST ESTIMATE

The overall cost estimate of the project amounts to: EUR 13.999.998,72 exclusive of VAT.

# 4. PROCUREMENT METHOD

The Bid will be the subject of a public bid opening. The Bid will be carried out in accordance with NATO NCB+ procedures (National Competitive Bidding plus) where the foreign bidders from "participating

countries" could also participate. The Hellenic Navy intends to apply the procurement method with single stage, according to relevant Greek Law No 4412/2016. To qualify for award of the Contract, bidders shall meet the minimum qualifying criteria as specified in the bidding documents. For the qualified companies, the criterion for awarding the contract is **the lowest biding price**.

#### 5. PROJECT CLASSIFICATION

The project is "NATO Unclassified". However, since works in the implementation level will take place on military restricted area, Contractor is obliged to certificate all staff members, according to national decree on security of the military area, prior to enter.

### 7. TYPE OF BIDDING

- 1. The bid submission system will be open, electronically bidding and is to be carried out in conformity with the provisions of law No 4412/2016.
- 2. The official language of bidding is Greek. Complete set of bidding documents in Greek language, including qualification requirements, bidding data sheet, "Cahier des Charges", technical specifications, drawings, bill of quantities, security guarantee and contract forms. The Bid prepared by the Bidder and all correspondence and documents relating to the Bid exchanged by the Bidder and the HNGS shall be written in the Greek language.
- 3. A complete set of bidding documents can be downloaded free of charge by the bidders on the EΣΗΔΗΣ website at <a href="http://www.promitheus.gov.gr">http://www.promitheus.gov.gr</a>. At Hellenic Navy's official website http://www.hellenicnavy.gr is hosted a declaration.
- 4. Questions and requests for clarifications should be obtained on <a href="http://www.promitheus.gov.gr">http://www.promitheus.gov.gr</a> portal only through «Online discussions».
- 5. Companies which are interested in participating in bidding are required to be registered on the website at http://www.promitheus.gov.gr in order to be authorized users.
- 6. For submitting bids, bidders are required to have Digital signature certificate issued by any certifying authority according to National Joint Ministerial Decision (KYA) No 83010/4098 (FEK 2710/B'/02-08-2017).
- 7. Bids must be submitted online only at website <a href="http://www.promitheus.gov.gr">http://www.promitheus.gov.gr</a>. Manual bids will not be accepted.

- 8. All the companies which intend to participate in bidding must submit a Letter of Guarantee (L/G) issued by a reputable bank located in Greece or abroad denominated in Euros equal to 279.999,97 and valid till one (1) month, after the end of the validity period of bids.
- 9. A single contract will be paced with one Contractor. No partial bidding shall be allowed.
- 10. All the foreign bidders from "participating countries" which intend to participate in bidding must submit their Declaration of Eligibility directly with all the necessary documents which are required according to Bidding procedure.
