- 1. The Ministry of National Defence/Türkiye of Republic (MoD) intends, in accordance with reference, to invite eligible to participate at National Competitive Bidding + (NCB+) for the implementation of works which are consist of the combination of Project 3NB 19023 "Construction of New Pier&Quay (Part-A) and Auxiliary Facilities", Prefinanced Project 3NB 19170 "POL Facilities and Related Insfrastructure of Pier/Quay" and Prefinanced Project 3NB 19171 "Construction of Quay and Related Infrastructure at Aksaz NB (Part-B)".
- 2. Scope and Location of the Project: An overview of the requirements for this IFB is as follows: All the below items will be constructed according to NATO Maritime Facilities Criteria and Standarts (Bi-SC 085-008), national/international maritime facilities design construction criterias and related legislations.
  - a. Quay (Part-A and Part-B, Total Lenght Appx: 1200 m), 1 (one) Pier (50x300 m) and Other (Auxiliary) Facilities, (Water storage, Base Support Building, POL Pump Stations&Depots, Electric Power Stations, Fire Fighting Building, Roads and Related Infrastrurcute Works. etc.)
  - b. All serviceability requirement of the Quay and Pier (sewage water, domestic water, rain water, waste water, pressured air, bilge water, fire water, fuel, electricity, communication, lighting lines and related equipments etc.),
  - Huge amount of hard material excavation and Quay back site qualified&controlled filling from seaside&landside,
  - d. Location: Aksaz Marmaris / Muğla.
- 3. Method of Bidding: National Competitive Bidding + (NCB+)

#### 4. Bidding Information:

- a. Companies from NATO member countries which are interested in participating in bidding be introduced by their National Delegations to NATO or Embassies in ANKARA through Ministry Foreing Affairs/Türkiye with the required Declaration of Eligibility document, before the eligibility closing date. The Declaration of Eligibility document should be submitted using the NATO form, which is available on the document AC/4-D/2261, Annex V. Application for participation directly from the companies shall not to be consider.
- b. It should be known that the technical, financal and professional decision of the candidate companies to be selected to participate in this tender has done or currently doing or has the capacity to do any of the Maritime Facilities (IAW National regulations, such as; pier, quay, breakwater, shipyard docks etc. with all the serviceability requirements) needs to be taken by the bidder's country. At the stage of bidding; provisional guarantee (%3 of the bid price) shall be submitted, at the stage of contract; final guarantee (% 6 of the bid price) shall be submitted to the MoD TÜ.
- c. It is kindly requested that the list of approved companies, which are candidates for participation in this tender, be notified to the Ministry of National Defence not later than 05 December 2025 (latest 18:00 local hours). The list of be notified should include the company's name, telephone and fax number, e-mail address and the personal to be contacted. This information is important
