### **Purpose**

- 1. In accordance with the provisions of Article XXXII of the NATO Financial Regulations and Financial Rules and Procedures, we are pleased to inform you that the NATO IS Procurement Service intends to issue RFP stated above and this is a NOI to inform the marketplace and NATO Delegations about this upcoming opportunity.
- a. The purpose of the NOI is to inform industry that NATO IS Procurement Service intends to establish a set of strategic Framework Agreements (FA) for Management Advisory Services (MAS+) including a wide range of consulting services to support principally NATO International Staff mission and objectives on simple and expeditious basis, as a result of the public solicitation.
- b. FAs duration: 5 years
- c. Principal Place of Performance: NATO HQ Brussels (BE); Remotely case by case
- d. Security Clearance: case by case

## **Governing Rules and Eligibility**

- 4. This procurement action will follow the Formal Procurement procedure specified in References A and B.
- 5. To be eligible to participate in the bidding process, Bidders must:
  - a. Be from one of the NATO Participating Nation
  - b. Have a sound financial and legal standing and sufficient capacity and resources to provide the products/services specified in the Statement of Work; and
  - c. Be otherwise qualified and eligible to receive an award under applicable NATO regulations.

#### Solicitation content and closing date

- 6. Offers will be solicited as Request For Proposal (RFP). Detailed instructions regarding the preparation, submission, and evaluation of proposals will be provided in Part I of the RFP (Instructions for the Preparation and Submission of Offers).
- 7. Aside from proof of the eligibility requirements stated above, Bidders may also be required to provide the following mandatory documentation as part of their proposals (Part I, Section 4 of the RFP will provide further details about the mandatory composition of proposals):
  - a) Statements of legal and financial condition and other statements and certificates required to verify Bidder's financial and legal standing;
  - b) Data on relevant past performance and subcontracting arrangements;
  - c) Information about the proposed approach, services and capabilities;
  - d) Elaboration of any deviations to the terms and conditions of the proposed contract;
  - e) Price proposal.

#### **Evaluation Criteria and Contract Award**

- 8. Bidders will be evaluated on the documentation submitted and other information and documentation available to the Organization (e.g. verification of past performance references). Considerations may include: understanding of requirements and proposed approach, proposed resources and capabilities, past performance; legal risks; and the proposed price.
- 9. The individual Framework Agreements will be awarded to the responsible Bidder(s) whose conforming proposal represents the best value after evaluation in accordance with the factors and sub-factors specified in the RFP. The detailed proposal evaluation factors, their relative importance, and the phases of the source selection process will be described in Part I of the RFP.
